Research reproducibility is a key concern across disciplines and stakeholder groups, including research funders, journals and scholarly societies, and has been coined as a “reproducibility crisis” a couple of years ago.

In this meeting we will look into the concept as a spectrum of terms and practices which aim to improve the transparency and reliability of research results. We will focus on how these concepts work out in practice, e.g. when implemented in the context of research projects, publishing or training and teaching.

Opis:	<p>The present Call for Proposals aims at funding projects in the area of reinforcing efforts to counter terrorist financing. Project applications submitted under the present Call for Proposals must address at least one of the following priorities:</p> <ol style="list-style-type: none"> 1. Facilitating cross-border exchange of financial information and promoting publicprivate cooperation. Projects should aim to enhance the quality and timeliness of the financial information shared at EU level, increase the involvement of regulated sectors other than retail banking, and/or develop technology that supports real-time sharing and analysis. Projects may build on existing mechanisms that enable supranational public-private cooperation. 2. Developing expertise in emerging terrorist financing risks related to crypto-assets, new payments systems, social media and/or crowd-funding. 3. Developing innovative investigative techniques in Member State law enforcement authorities responsible for counter-terrorism financial investigations, including for conducting parallel investigations, exploiting associated “non-financial” information, examining terrorist links to other criminal activity and on use of Artificial Intelligence, machine learning or robotics for investigations.

Opis:	<p>The European Commission has launched the first call of the Innovation Fund for Large Scale Projects, with a first-stage deadline of 29 October 2020. The Innovation Fund, announced in 2019, finances demonstration of innovation low-carbon technologies that can contribute to limiting climate change.</p> <p>In particular, the fund will support innovative low-carbon technologies and processes in energy-intensive industries, carbon capture and utilisation (CCU), carbon capture and storage (CCS), innovative renewable energy generation and energy storage.</p> <p>To be eligible, projects must have total capital expenditure of more than 7.5 million EUR and be located in the EU, Norway or Iceland, and last no more than four years. Participation of the UK will depend on the final form of the UK-EU relationship after the transition period ends in December 2020.</p>

	<p>Project grants will cover up to 60% of costs, and applicants may be multi-entity consortia or single organisations, including public bodies.</p> <p>Seventy projects from the first-stage will be selected to advance to the second stage, which will have a deadline of 23 June 2021. In the first stage, proposals will be assessed on their absolute and relative greenhouse gas emission avoidance, the degree of innovation, and project maturity. In the second phase, scalability and cost efficiency will also be assessed.</p> <p>Up to forty of the project proposals that do not make it to the second phase may be considered for Project Development Assistance from the European Investment Bank.</p> <p>Applications for small scale projects (below 7.5 million EUR) will launch by the end of 2020.</p> <p>More details can be found in the Call Text and via the EC Funding and Tenders Portal.</p>
